The Executive Direct explained this was a mini grant, for \$500,

for the library, unfortunately First 5 Glenn County and 16 other counties were not accepted.

The Commission received a list of Assembly and Senate Bills that First 5 California identified as beneficial to the work they do and the families they serve. They were informed that all hearing on these bills are in process and would be heard throughout the month of March and April 2019. Results could be found of these bills within the May Budget Revise coming up.

Commission received information on the importance of Early Childhood Screenings as perceived by Assembly Member Keven McCarty. Executive Director explained that First 5 Glenn County does multiple screenings since it is a gap program and that this bill would ask for county data to be inclusive.

Commission was informed of the conversation between the Local Valley Mirror owner and First 5 Glenn County's Executive Director. The Valley Mirror owner had a concern that First 5 Glenn County was using local Prop 10 money to pay for this billboard. Randy Jones from Glenn County Office of Education said that the Valley Mirror owner also contacted them about this matter and was wanting know if a payment to a billboard company was made by First 5 Glenn County, Mr. Jones then asked are you sure it's not First 5 California.

PLEASE WELCOME LISA WATSON FROM SOCIAL ENTREPRENEUR'S INC (SEI)

2019 - 2022 STRATEGIC PLAN & FINANCIAL FORECAST

Pursuant to Health and Safety Code Section 130140 (a)(1)(D)(E)(F).

**Due to lack of Quorum, this was only a presentation and no action was taken by the Commission members present.

Lisa Watson from SEI presented the 2019 - 2022 STRATEGIC PLAN & FINANCIAL FORECAST. This would be finalized at the June 5th, 2019 meeting.

- The New Strategic Plan and Financial Forecast is a more stream line approach that makes it more consumable and had a better fit to our commission and what First 5 Glenn County needs.
- It creates an alignment between the Evaluation and Annual Report and Budget of First 5 Glenn County, legislation and state Commission.
- This document is now a 3 year plan instead of a 5 year plan, and it will only be updated if there is a major shift in the way First 5 Glenn County is funding or in priorities. By taking out the achievements component, this allows the plan to remain the 3 years, if there is an update it will be an update version 1.0 (with date).
- Vision and mission statement
- Four focus areas required by the state1.Family Functioning, 2. Child Development, 3. Child Health and 4. Systems of Care and a definition of what each of these Focus areas accomplish to meet State wide requirements.
- A mini needs assessments was necessary to validate the initial approach of Little Learners Program, this gives an overview of Glenn County Demographics: population projections- by range age, and 1-5 years.
- ACES frame work and information, and how Aces impacts Glenn County, but Glenn County is still in the training phase, but this holds the place in the document for future updates.
- The priorities of First 5 Glenn County being Families, Partners and Systems that guide the investments. This would help to build the alignment between the Strategic Plan and the Evaluation and Annual Report and not have gaps. To better speak of how well First 5 is achieving their strategic plan and not just how well they are serving families. This shows a more streamline or reduces scope of focused group. Having a more focused approach better serves the limited pool of funds and shows what it will be used for Instead of having a wish list of all the things we want to do but are not in the capacity to do so.
- Strategic Plan Matrix: what is the goal and the objects and how First 5 Glenn County is going to accomplish these objectives. The performance indicators with tables and charts and the outcome indicators create an alignment between the Strategic Plan and the Evaluation Report.
- Slight modification and changes before June 5th meeting will be done on the Financial Forecast section. First 5 California wants to move to the

direction of funding instead of direct services, but at this time being a small county First 5 Glenn County is not at capacity to fund. It has had to condense programs and cut hours on personnel to get through this year. Maybe at year 3 funding might be a consideration and revisit this and insert it back into the Financial Forecast when applicable. First 5 Glenn County is shaped by the needs of its community. This will drive the annual Budgeting process which creates alignment with the Annual Budget in this new plan.

- Diversity funding sources had not had to in the past, but due to decline in revenue, if SPCFA does not happen, First 5 Glenn County should be looking into this.
- The Data base that SEI was supposed to do for the Data collecting of First 5 Glenn County did not work out, and there will be credit moving forward into next year, in the cost of the creation on that data base. Data should be still sent to Lisa to put into spread sheet so that when other data program arrangements are made the data is ready.
- With this Financial Forecast we are stabilizing existing operations from the first year on.

Comments:

- Executive Director took this opportunity to thank GCOE and Randy Jones for the donation of the van that was lent First 5 Glenn County, and for the opportunity to better serve their families now that transportation is no longer an issue.
- Next year there will not be AmeriCorps due to decline in revenue.
- Commissioner Wathen thanked Lisa for making the document so easy to read and comprehend to better transfer the information to anyone who wants it.
- Executive Director explained the situation with the loss in the sheds in the back lot, and how Golden State Risk Management was going to take care of the case.
